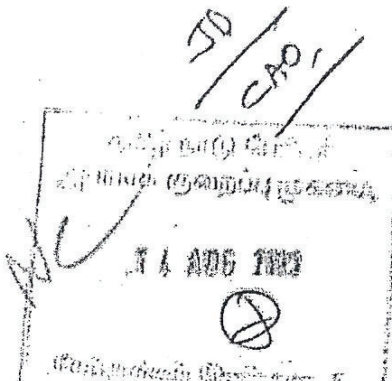

From the Deputy Secretary (FCD), Government of India, Ministry of Finance, Department of Expenditure, Finance Commission Division, Letter No.13(2)/FCD/2023-24, dated 10.07.2023.

ORDER:

In the letter read above, the Government of India has released a sum of Rs.450,00,00,000/- (Rupees Four hundred and fifty crore only) to the Government of Tamil Nadu as first installment of the Government of India's contribution to the State Disaster Response fund for the year 2023-2024.

2. The Government direct that a sum of Rs.600,00,00,000/- (Rupees Six hundred crore only) comprising first installment of Government of India's contribution of Rs.450,00,00,000/- (Rupees Four hundred and fifty crore only) and the corresponding State's contribution of Rs.150,00,00,000/- (Rupees One hundred and fifty crore only) for the year 2023-2024 be transferred to the State Disaster Response Fund.

3. The expenditure shall be debited to the following head of account:-

 - 05 State Disaster Response Fund
 - 101 Transfer to Reserve Funds and Deposit Accounts - State Disaster Response Fund State's Expenditure
 - AC Transfer to State Disaster Response Fund
 - 330 Inter-Account Transfers
 - 01 Inter-Account Transfers (IFHRMS DPC 2245 05 101 AC 33001)

and contra credited to

- 8121 00 General and other Reserve Funds
 - 122 State Disaster Response Fund
 - AA State Disaster Response Fund and Deposit Accounts - State Disaster Response Fund
- 801 Receipts
 - 01 Bearing Interest (IFHRMS DPC 8121 00 122 AA 80101) (Receipts)

4. The transfer shall be effected by the Principal Accountant General (A & E) in the books of Accounts for the year 2023-2024. The Principal Accountant General is requested to furnish a certificate to the effect that the amount has been credited to the State Disaster Response Fund.
