ORDER:

In the letter read above, the Government of India has released a sum of Rs.450,00,00,000/- (Rupees Four hundred and fifty crore only) to the Government of Tamil Nadu as second installment of the Government of India's contribution to the State Disaster Response Fund for the year 2023-2024.

2. The Government direct that a sum of Rs.600,00,00,000/- (Rupees Six hundred crore only) comprising second installment of Government of India's contribution of Rs.450,00,00,000/- (Rupees Four hundred and fifty crore only) and the corresponding State's contribution of Rs.150,00,00,000/- (Rupees One hundred and fifty crore only) for the year 2023-2024 be transferred to the State Disaster Response Fund.
