#### ORDER:

In the letter read above, the Government of India has released a sum of Rs.428,40,00,000/- to the Government of Tamil Nadu as first installment of the Government of India's contribution to the State Disaster Response fund for the year 2022-2023.

- 2. The Government direct that a sum of Rs.571,20,00,000/- (Rupees five hundred and seventy one crore and twenty lakh only) comprising first installment of Government of India's contribution of Rs.428,40,00,000/- and the corresponding State's contribution of Rs.142,80,00,000/- for the year 2022-2023 be transferred to the State Disaster Response Fund.
