**ORDER:**

In the letter third read above, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has stated that the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested to Revised Administrative Sanction for an amount of Rs.1566.65 Lakhs towards construction of a new tail end regulator across Uppanar Drain near Pitchavaram Village to arrest sea water intrusion in Chidambaram taluk of Cuddalore District and reported as follows:-

- a) The Government will taken permanent Flood Mitigation Works in Chennai, Kancheepuram, Chengalpattu, Tiruvallur and Cuddalore districts to a total cost of Rs.284.70 Crore.

- b) Accordingly, based on the proposal of Additional Chief Secretary/ Commissioner of Revenue Administration, the Government have accorded Administrative Sanction for twelve works to carrying out long term flood mitigation works in Chennai, Tiruvallur, Kancheepuram and Cuddalore districts at an estimated cost of Rs.238.13 crores in the Government order first read above. The above work is one among the 12 works at an estimated cost of Rs.1525.45 lakhs.
- c) The above work had been technically sanctioned for Rs.1525.45 lakhs by the Chief Engineer, WRD, Chennai Region. Tenders for the above work was called for by the Superintending Engineer, Vellar Basin Circle, Cuddalore for Rs.1518.26 lakhs with a tender premium of (+) Rs.72,09,249/- or (+) 4.99% excess over the departmental value put to tender. The work was commenced on 19.02.2019 and physically completed on 30.06.2022.
- d) Due to the excess in the tender premium of Rs.72,09,249/-, the total expenditure to complete the work become Rs.1566.65 lakhs to the net excess of Rs.41,19,860/- over the sanctioned estimate cost of Rs.1525.45 Lakhs. This Revised Administrative sanction proposal had been placed before the Technical Advisory Committee during it's 49th meeting held on 08.01.2021 and the committee had recommended the proposal to Government for Rs.1597.54 lakhs. The Revised Administrative Sanction proposal had also been placed before the Tender Award Committee during its 378th meeting held on 22.06.2021 and the committee had also recommended this proposal to Government for Rs.1566.65 lakhs.
- e) The Engineer-in-Chief and Chief Engineer (General), Water Resource Department, Chennai has requested to obtain Revised Administrative sanction for a sum of Rs.1566.65 Lakhs towards construction of a new tail end regulator across Uppanar Drain near Pitchavaram Village to arrest sea water intrusion in Chidambaram taluk of Cuddalore District for which the original sanction was accorded in the Government order first read above.

2. The Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has recommended the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resource Department, Chennai requesting Revised Administrative Sanction for Rs.1566.65 Lakhs (originally sanctioned Rs.1525.45 Lakhs vide in the Government order first read above) towards the work of "Construction of a new tail end regulator across Uppanar Drain near Pitchavaram Village in Chidambaram taluk of Cuddalore District" to arrest sea water intrusion to the Government for approval.



3. The Government after careful examination of the proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner hereby accord Revised Administrative Sanction for a sum of Rs.15,66,65,000/- (Rupees Fifteen Crore Sixty Six Lakh and Sixty Five Thousand only) from the state fund towards the work of "Construction of a new tail end regulator across Uppanar Drain near Pitchavaram Village in Chidambaram taluk of Cuddalore District" to arrest sea water intrusion against the original Administrative sanction amount of Rs.15,25,45,000/- and also accord financial sanction for a sum of Rs.41,20,000/- for the current Financial Year 2023-2024.

4. The amount sanctioned in paragraph 3 above shall be debited to the following head of account: -

"2245 Relief on Account of Natural Calamities 02 Flood, Cyclones, etc., 800 Other Expenditure State's Expenditure BU Disaster Preparedness Flood Mitigation Works in the Highly Vulnerable areas 317 Minor Works - 01 Minor Works"

5. The expenditure sanctioned in Para 3 above shall constitute an item of "New Instrument of Service" for which the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Additional Chief Secretary/Commissioner of Revenue Administration and State Relief Commissioner is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send necessary explanatory note to the Government in Finance (B.G.I/ Revenue) Department for inclusion of the expenditure in the Supplementary Estimates for the year 2023-2024 for getting the approval of the Legislature at an appropriate time without fail.
