ORDER:

In the letter sixth read above, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has stated as follows: -

- i) The Engineer-in-Chief, Water Resources Department, Chennai has stated that, the State Executive Committee, during their meeting held on 04.09.2021 have agreed to recommend 10 mitigation project proposals of Water Resources Department to the Government, for sanction of funds under State Disaster Response Fund. Out of the above 10 mitigation project proposals, the work of "Formation of Cut & Cover macro drain from Irumbuliyur Tank to GST Road, Peerkankaranai Flood Regulator to Irumbuliyur Macro Drain, link drain from GST Road under tunnel to the Mudichur Road Cut & Cover junction in Tambaram Taluk of Chengalpattu District" at an estimated cost of Rs.60.00 crore at 2021-2022 Schedule of Rates. Since, Administrative Sanction could not be obtained for the works recommended by State Executive Committee (SEC) the same has been re-casted to the current Schedule of Rates (2022-23) for a value of Rs.75.00 crore and submitted to Engineer-in-Chief, Water Resources Department to obtain necessary Administrative Sanction for the above work from the Government.
- ii) Since, the work could not be taken up for want of Administrative and Financial sanction during 2021-22, the estimate for the most prioritised work of the above works viz., "Formation of Cut & Cover macro drain from Irumbuliyur Tank to GST Road, Peerkankaranai Flood Regulator to Irumbuliyur Macro Drain, link drain from GST Road under tunnel to the Mudichur Road Cut & Cover junction in Tambaram Taluk of Chengalpattu District" has been re-casted to current schedule of rates and sent to Government for obtaining necessary Administrative Sanction to explore the feasibility of funding under State Disaster Risk Management Fund (SDRMF) at an estimated cost of Rs.96.50 Crore with drain wise cost for the civil works is furnished below:-

iii) The proposal of the Engineer-in-Chief, Water Resources Department for sanction of Rs.96.50 Crore for the work of "Formation of Cut & Cover macro drain from Irumbuliyur Tank to GST Road, Peerkankaranai Flood Regulator to Irumbuliyur Macro Drain, link drain from GST Road under tunnel to the Mudichur Road Cut & Cover junction in Tambaram Taluk of Chengalpattu District" has been

examined in detail and it is found eligible for sanction of funds under State Disaster Mitigation Fund (SDMF).

2. The Additional Chief Secretary/ Commissioner of Revenue Administration & State Relief Commissioner has therefore recommended to the State Executive Committee for sanction of an amount of Rs.96.50 crore to Water Resources Department for the execution of work of "Formation of Cut & Cover macro drain from Irumbuliyur Tank to GST Road, Peerkankaranai Flood Regulator to Irumbuliyur Macro Drain, link drain from GST Road under tunnel to the Mudichur Road Cut & Cover junction in Tambaram Taluk of Chengalpattu District" under State Disaster Mitigation Fund (SDMF).

3. The above said proposal (Proposal No.11) was discussed and approved in the State Executive Committee Meeting held on 08.09.2023 under the chairmanship of the Chief Secretary to Government. Minutes of the meeting is available in the seventh read above.

4. The Government after careful examination of the proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner and based on the approval of the State Executive Committee, sanction is hereby accorded for a sum of Rs.96,50,00,000/- (Rupees Ninety Six Crore and Fifty Lakh Only) under State Disaster Mitigation Fund (SDMF) to the Engineer-in-Chief & Chief Engineer (General), Water Resources Department for the work of "Formation of Cut & Cover macro drain from Irumbuliyur Tank to GST Road, Peerkankaranai Flood Regulator to Irumbuliyur Macro Drain, link drain from GST Road under tunnel to the Mudichur Road Cut & Cover junction in Tambaram Taluk of Chengalpattu District".

5. The amount Sanctioned in para 4 above shall be debited to the following heads of account: -

"2245 Relief on Account of Natural Calamities 02 Flood, Cyclones, etc., 102 Drinking Water Supply - State's Expenditure AB Storm Water Drains and Water Supply Schemes under Corporations, Local Bodies and Autonomous Bodies 309 Grants-in-Aid 09 others."

6. Necessary additional funds of Rs.96,50,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023-2024. Pending provision of such funds, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner is authorized to draw and disburse the amount. This expenditure should be brought to the notice of

Legislative Assembly by the way of Specific Inclusion in the Supplementary Estimates 2023-2024. The Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner is directed to include the expenditure sanctioned above, while sending the Budget Proposal for Revised Estimate/ Final Modified Appropriation 2023-2024 and also to send necessary Explanatory Notes to Finance (Revenue) Department for including the above expenditure in the Supplementary Estimates 2023-2024 without fail.

7. This order issues with the concurrence of Finance Department vide e-file No.12067/Finance (Revenue)/2023, dated:20.10.2023 and ASL No.1132 (One Thousand One Hundred and Thirty Two) (IFHRMS ASL No.2023101132).
