ORDER:

In the letter third read above, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has stated as follows: -

- I. In the meeting convened by the Additional Chief Secretary to Government, Municipal Administration and Water Supply Department to discuss to construction of storm water drain in Greater Chennai Corporation and the surrounding urban local bodies, it was decided to sanction funds for the Greater Chennai Corporation and Director of Municipal Administration.
- II. The Additional Chief Secretary/ Commissioner of Greater Chennai Corporation has stated as follows:
 - ▶ During Monsoon 2021, several areas in Chennai has been severely affected due to rain water stagnation and subsequently new Storm water drain network of 219.76 Km has been taken up and so far, 165 Km length of Strom Water Drain have been completed in the year 2021-22, due to which rain water stagnation was avoided in most of the areas.

- The Additional Chief Secretary/ Municipal Administration and Water Supplies Department in the review meeting regarding flood measures has instructed to take up the balance Storm water drain network required to avoid stagnation of rain water in all areas in future. Also, it was instructed to engage hydrological consultant for detailed study of the catchment area of the newly proposed drains and arrive at the design of Stormwater drain.
- ➢ In this regard, a High-level Committee meeting was conducted by Additional Chief Secretary to Government, Municipal Administration and Water Supplies Department and Additional Chief Secretary/ Commissioner of Revenue Administration and Disaster Management on 28.02.2023 to discuss the construction of stormwater drain in Greater Chennai Corporation and the surrounding urban local bodies.
- During this meeting, it was instructed to invite tenders for the construction of Stormwater drains at an estimated cost of Rs.232.35 crore for Greater Chennai Corporation in anticipation of Administrative Sanction subject to the condition that the Detailed Project Report for the Stormwater drain works has to be appraised by Tamil Nadu Urban Finance and Infrastructure development Corporation Ltd.(TUFIDCO) and work orders to be issued only after issuance of Government Order.
- III. The suggested source of funding as per the minutes of the meeting is as follows:-

V. The Detailed Project Report for the Stormwater drain works in various locations in various Zones has been appraised by Tamil Nadu Urban Finance and Infrastructure development Corporation Ltd.(TUFIDCO) and based on this, in anticipation of

- Administrative Sanction by Government, tenders have been called in 38 packages for the works (as detailed in Annexure-I).
- VI. The total amount of Rs.291.35 crore has been released under State Disaster Mitigation Fund (SDMF) 2022-2023 and the savings amount of Rs.27.98 crore is available with Greater Chennai Corporation.
- VII. It is stated that, the Additional Chief Secretary/ Commissioner of Greater Chennai Corporation has requested for according approval and administrative sanction for the storm water drain works for an estimated cost of Rs.187.98 core under State Disaster Mitigation Fund (SDMF) and for releasing an amount of Rs.160 crore and for utilizing the savings amount of Rs.27.98 crore under State Disaster Mitigation Fund (SDMF) 2022-2023 which is available with Greater Chennai Corporation.
- VIII. The Director of Municipal Administration has stated as follows: -
 - The Additional Chief Secretary to Government, Municipal Administration and Water Supplies Department has convened a high-level meeting for construction of storm water drains in Chennai and sub-urban areas for availing fund under State Disaster Response Fund (SDRF)/ National Disaster Response Fund (NDRF).
 - ➤ The Committee permitted to invite tenders for construction of storm water drains at an estimated cost of Rs. 144.00 crore to the Director of Municipal Administration and in anticipation of Administrative Sanction subject to the condition that the detailed project reports/ proposals to be appraised by Tamil Nadu Urban Finance and Infrastructure development Corporation Ltd.(TUFIDCO) and work orders to be issued only after the issue of Administrative Sanction of these works with the approval of Government.
 - > Tamil Nadu Urban Finance and Infrastructure development Corporation Ltd.(TUFIDCO) has appraised the 42 numbers of works at a cost of Rs.114.04 crore and 13 number of works at Rs.34.68 crores.
 - Provisional sanction for 53 works has been issued to Urban Local Bodies to an amount of Rs.145.24 crore and tender notice has been published and tender was fixed on 26.04.2023 and administrative sanction for 2 works has been issued to Thiruverkadu Municipality.
 - ➤ In this connection the Director of Municipal Administration has requested to approve the following works under State Disaster Mitigation Fund (SDMF) for the year 2023 2024.

- IX. The Director of Municipal Administration has further stated that as the sanctioned amount under State Disaster Mitigation Fund (SDMF) is 14400.00 lakhs 53 works will be taken under this scheme. The appraised value of the works are Rs.14524 Lakhs and the excess amount of Rs.124.00 lakhs will be contributed from General Fund of Tiruverkadu Municipality. [The list of proposed 53 works as detailed in Annexure-II]
- X. Hence, the Director of Municipal Administration has requested an amount of Rs.144.00 Crore under State Disaster Mitigation Fund (SDMF) towards the Construction of Storm Water Drains in Chennai and Sub – Urban areas during the financial year 2023-2024.
- XI. The High-Level Committee instructed the Principal Secretary/ Commissioner, Greater Chennai Corporation to submit the utilisation certificate for the funds sanctioned under State Disaster Mitigation Fund 2022-2023 declaring a savings of Rs.27 crore, which can be used by Greater Chennai Corporation against the fresh sanction.
- XII. The High-Level Committee considered the proposal of the Principal Secretary/ Commissioner, Greater Chennai Corporation and Director of Municipal Administration and considering the importance of storm water drains in draining storm water and preventing floods, the committee permitted them to invite tenders for construction of storm water drains at an estimated

cost of Rs.376.35 crore. (Greater Chennai Corporation – Rs.232.35 crore and Director of Municipal Administration – Rs.144 crore) in anticipation of administrative sanction subject to the condition that the Detailed Project Reports/ Proposals to be appraised by Tamil Nadu Urban Finance and Infrastructure development Corporation Ltd.(TUFIDCO) and work orders to be issued only after Government Order is issued according administrative sanction for these works.

- XIV. In this connection, the following points are furnished below:-
 - The Government have sanctioned a sum of Rs 373.50 crore towards implementation of the mitigation work in the Greater Chennai Corporation area and its suburban area. Accordingly, a sum of Rs.291.35 crore and Rs.82.15 crore have been sanctioned to the Principal Secretary/ Commissioner, Greater Chennai Corporation and the Director, Directorate of Municipal Administration respectively vide Commissioner of Revenue Administration's proceedings Dated 26.05.2023.
 - ➤ The Principal Secretary/ Commissioner, Greater Chennai Corporation and the Commissioner, Directorate of Municipal Administration have been requested to send the Utilization Certificate vide Commissioner of Revenue Administration's letter Dated:13.04.2023 and the Utilization Certificate is awaited.
- XV. In case, if the mitigation works mentioned in Annexure-I and Annexure-II are taken up under any other schemes, the funds allotted for those works would be diverted to other mitigation works.
- 2. The Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has therefore requested to the proposal of the Additional Chief Secretary / Commissioner of Greater Chennai Corporation for according administrative approval for Rs.187.98 crore and for sanction of Rs.160.00 crore towards construction of storm water drains under State Disaster Mitigation Fund (SDMF) during

the financial year 2023-2024 with permission to utilise the savings of Rs.27.98 crore from out of the funds sanctioned for mitigation works during the year 2022-2023, may be placed before the State Executive Committee for according approval and sanction of funds in anticipation of release of 2nd instalment under State Disaster Mitigation Fund (SDMF) for the year 2022-2023 and allocation under State Disaster Mitigation Fund (SDMF) for the year 2023-2024. With the condition that if the above mitigation works are sanctioned under the UFRMP of NDMF (Urban Flood Risk Management Programme of National Disaster Mitigation Fund) the above amount would be surrendered to State Disaster Mitigation Fund (SDMF) account for utilisation for other mitigation works. Further the proposal of Director of Municipal Administration for sanction of Rs.144.00 Crore towards construction of Storm water Drains Sub-Urban areas and Cuddalore Municipal Corporation from State Disaster Mitigation Fund during the financial year 2023-2024 may also be placed before the State Executive Committee for according approval and sanction of funds in anticipation of release of 2nd installment under State Disaster Mitigation Fund (SDMF) for the year 2022-2023 and allocation under State Disaster Mitigation Fund (SDMF) for the year 2023-2024.

- 3. The Government after careful examination, accept the proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner and based on the approval of the State Executive Committee and hereby orders the followings:
 - i) To accord administrative approval for Rs.187,98,00,000/- to the Commissioner of Greater Chennai Corporation and for financial sanction of Rs.160,00,00,000/- (One Hundred and Sixty Crore only) towards construction of storm water drains under State Disaster Mitigation Fund (SDMF) during the financial year 2023-2024 with permission to utilise the savings of Rs.27,98,00,000/- (Rupees Twenty Seven Crore and Ninety Eighty lakhs only) from out of the funds sanctioned for mitigation works during the year 2022-2023 and sanction of funds in anticipation of release of 2nd instalment under State Disaster Mitigation Fund (SDMF) for the year 2022-2023 and allocation under State Disaster Mitigation Fund (SDMF) for the year 2023-2024, with the condition that if the above mitigation works are sanctioned under the UFRMP (Urban Flood Risk Management Programme) of National Disaster Mitigation Fund (NDMF) the above amount should be surrendered to State Disaster Mitigation Fund (SDMF) account for utilisation for other mitigation works;
 - ii) To sanction a sum of Rs.144,00,00,000/- (Rupees One Hundred and Forty Four Crore only) to the Director, Municipal Administration towards construction of Storm water Drains Sub-Urban areas and Cuddalore Municipal Corporation from State Disaster Mitigation Fund (SDMF) during the financial year 2023-2024 and sanction of funds in anticipation of release of 2nd installment under State Disaster Mitigation Fund (SDMF) for the year 2022-2023 and

allocation under State Disaster Mitigation Fund (SDMF) for the year 2023-2024.

4. An amount of Rs.304,00,00,000/- sanctioned in paragraph 3 above shall be debited to the following head of account:-

"2245 Relief on Account of Natural Calamities – 02. Flood, Cyclones, etc., - 102 Drinking Water Supply – State's Expenditure AB Storm Water Drains and Water Supply Schemes under Corporation, Local Bodies and Autonomous Bodies 309 Grants-in-Aid 09 others."

- 5. Necessary additional funds of Rs.304,00,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023-2024. Pending provision of such funds, the Additional Chief Secretary/ Revenue Administration State Commissioner of and Commissioner is authorised to draw and disburse the amount to the Commissioner, Greater Chennai Corporation and the Director of Municipal Administration. This expenditure should be brought to the notice of Legislative Assembly by the way of Specific Inclusion in the Supplementary Estimates 2023-2024. The Additional Chief Secretary/ and State Commissioner Revenue Administration of Commissioner is directed to include the expenditure sanctioned above, while sending the Budget Proposal for Revised Estimate/ Final Modified Appropriation 2023-2024 and also to send necessary Explanatory Notes to Finance (BG-I/Revenue) Department for including the above expenditure in the Supplementary Estimates 2023-2024 without fail.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.03/ JS(KU)/ Finance(Revenue)/ 2023, dated 21.06.2023 and ASL No.340 (Three Hundred and Fourty) (IFHRMS ASL No.2023060340)
