

ABSTRACT

Disaster management – Cyclone Michaung (Migjaum) in Chennai, Tiruvallur, Chengalpattu and Kancheepuram Districts – Unprecedented Extremely Heavy Rainfall in Southern Districts – Sanction a sum of Rs.28,10,93,200/- Under the funding window of "Response & Relief" of State Disaster Response Fund (SDRF) to the Commissioner of Fisheries towards relief and restoration activities – Orders - Issued.

ORDER:

During the Northeast Monsoon 2023, the Cyclonic Storm "MICHAUNG" (Migjaum) over West central and adjoining Southwest Bay of Bengal off south Andhra Pradesh and adjoining north Tamil Nadu coasts moved north westwards and intensified into a Severe Cyclonic Storm and passed near North Tamil Nadu coast on 04.12.2023 with a maximum sustained wind speed of 60-70 kmph gusting to 80 kmph and caused extremely heavy rainfall in Chennai, Tiruvallur, Kancheepuram and Chengalpattu Districts.

- 2. Further, unprecedented extremely heavy rainfall/ Flood occurred in Thoothukudi, Kanniyakumari, Tirunelveli and Tenkasi Districts from 15.12.2023 onwards and the fishing boats, fishing implements and Fish farms were damaged.
- 3. In the letter sixth read above, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has sent the proposal of Commissioner of Fisheries and stated as follows:-

A. "MICHAUNG" (Migjaum) Cyclone:

- a) In order to monitor the deep sea fishing vessels during the "MICHAUNG" (Migjaum) Cyclone, dedicated control rooms have
 been established at all coastal Districts. Central Control Room
 located at Commissionerate is functioning round the clock at Head
 Quarters and continuously contacting the district control rooms and
 updating the latest weather warnings. However, during the cyclonic
 storm on 04.12.2023, the boats that were berthed in the harbours
 and landing centers were severely affected and heavily damaged
 due to high speed wind and heavy rainfall during the cyclone.
- b) To assess the impending cyclone, 11 teams were formed with department officials, to assist the concerned Assistant Director of Fisheries and Fishermen Welfare in Chennai, Tiruvallur, Kancheepuram and Chengalpattu Districts and requested to submit detailed damage assessment report with relevant photographs and documents.
- c) In continuation, the Assistant Director of Fisheries and Fishermen Welfare, Nagapattinam has requested to provide relief amount of Rs.7,50,000/- towards fully damaged Mechanized Fishing Boat bearing register number IND-TN-06-MM-804. As per the damage assessment teams report damages to boats and fishing implements caused by Michaung Cyclone towards compensation for Rs.1313.22 Lakh and damages to fishing infrastructure for Rs.414.00 Lakh respectively.
- d) For rescue operation a total of 40 officials were deputed to make arrangements and to send the boats for rescue operation. From 04.12.2023 onwards a total of 450 FRP boats, 96 coracles and 1195 fisherman were deployed to the needy places. Rs.177.63 Lakh required for expenditure of boat rescue operation including boat hire charges, food allowances, vehicle and crane charges.
- e) Therefore, the Commissioner of Fisheries has requested to sanction a sum of Rs.1904.85 Lakh (Rs.1313.22 + Rs.414.00 + Rs.177.63) towards compensation to the Fishing crafts and Fishing implements and the losses and damages caused due to MICHAUNG cyclone and rescue operations carried out in Chennai, Tiruvallur, Kancheepuram and Chengalpattu Districts.

B. (Extremely Heavy Rainfall / Flood in Southern Districts)

- a) Extremely heavy rainfall / Flood was occurred in Thoothukudi, Kanniyakumari, Tirunelveli and Tenkasi Districts from 15.12.2023 onwards and the fishing boats that were berthed in the harbours and landing centers, fishing implements and Fish farms were damaged due to very heavy rainfall / Flood.
- b) 12 rescue teams were formed with a total of 40 department officials/ staff and requested to coordinate with concerned district coordinating/ monitoring officers to make necessary arrangements and to send the boats for rescue operation in Thoothukudi, Kanniyakumari and Tirunelveli districts. In continuation to this, from 18.12.2023 onwards a total number of 183 boats and 62 coracles were deployed from Thoothukudi, Tirunelveli, Ramanathapuram, Kanniyakumari and Chengalpattu districts to the needy places.
- c) In this connection, a sum of Rs.104.905 Lakh is proposed towards the actual expenditure of boat hire charges, food allowances to the fishermen those who involved in rescue operations and vehicle carried the boats and crane charges.
- d) 13 other teams were formed with a total of 54 department officials/ staffs to assist the concerned Assistant Director of Fisheries and Fishermen welfare in Thoothukudi, Kanniyakumari, Tirunelveli and Tenkasi Districts to carry out the damage assessment works and the teams have been requested to submit the detailed damage assessment report with relevant photographs and documents under the overall supervision of the Additional Director of Fisheries and Fishermen Welfare (Inland).
- e) Based on the report of damage assessment teams, the Commissioner of Fisheries has requested to sanction a sum of Rs.5824.36 lakh towards compensation to the Fishing crafts and Fishing implements on the losses and damages caused due to very heavy rainfall/ flood and rescue operations carried out in Thoothukudi, Kanniyakumari, Tirunelveli and Tenkasi Districts.
- f) The above proposals of the Commissioner of Fisheries have been examined with the norms prescribed in Government Order first read above and total sum of Rs. 2741.30 Lakh (Rs. 1288.13 lakhs ("Michaung" cyclone) & Rs. 1453.17 lakh (Flood)) is found eligible for sanction under State Disaster Response Fund (SDRF) as detailed below:

- 4. The Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has therefore recommended the proposal of the Commissioner of Fisheries as follows:
 - a) To sanction Rs. 1288.13 lakhs (Rupees One Thousand Two Hundred and Eighty Eight Lakhs and Thirteen Thousand Only) Under the funding window of "Response & Relief" of State Disaster Response Fund (SDRF) to the Commissioner of Fisheries towards relief and restoration activities in view of the damages caused due to "MICHAUNG" (MIGJAUM) Cyclone in Chennai, Tiruvallur, Chengalpattu, Kancheepuram and Nagapattinam Districts.
 - b) To sanction Rs. 1522.802 lakhs (Rupees One Thousand Five Hundred Twenty Two Lakhs Eighty Thousand and Two Hundred Only) Under the funding window of "Response & Relief" of State Disaster Response Fund (SDRF) to the Commissioner of Fisheries towards relief and restoration works in view of the damages caused due to Extremely Heavy Rainfall/ Flood in Southern Districts 2023.
- The Government after careful examination, accept the proposal of the Additional Chief Secretary / Commissioner of Revenue Administration and State Relief Commissioner and based on the approval the Executive Committee, hereby sanction sum Rs. 28,10,93,200/- (Rupees Twenty Eight Crore Ten Lakh Ninety Three Thousand and Two Hundred Only) (Rs.1288.13 lakh ["Michaung" (cyclone) and Rs.1522.802 lakh (Flood in Southern Districts 2023)] Under the funding window of "Response & Relief" of State Disaster Response Fund (SDRF) to the Commissioner of Fisheries towards relief and restoration activities in view of the damages caused due to "MICHAUNG" (MÍGJAUM) Cyclone in Chennai, Tiruvallur, Chengalpattu, Kancheepuram and Nagapattinam Districts and relief and restoration works in view of the damages caused due to Extremely Heavy Rainfall / Flood in Southern Districts 2023.
- 6. The amount sanctioned in para 5 above shall be debited to the following head of account: -

2245 Relief on Account of Natural Calamities - 02 Flood, Cyclones etc., - 118 Assistance for Repairs / Replacement of damaged boats and Equipment for fishing - State's Expenditure - AA Relief Measures to Fishermen - 351 Compensation - 02 Other Compensations.

7. Necessary additional funds of Rs. 28,10,93,200/- will be provided in Final Modified Appropriation 2023-2024. Pending provision of such funds, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner is authorized to draw and disburse the amount. This expenditure should be brought to the notice of Legislative Assembly by the way of Specific Inclusion in the Supplementary Estimates 2023-2024. The Additional Chief Secretary/

Commissioner of Revenue Administration and State Relief Commissioner is directed to include the expenditure sanctioned above, while sending the Budget Proposal of Final Modified Appropriation 2023-2024 and also send necessary Explanatory Notes to Finance (Revenue) Department for including the above expenditure in the supplementary Estimates 2023-2024, without fail.
