Disaster Management – Michaung Cyclone 2023 - Sanction a sum of Rs.45,43,61,545/- Input subsidy under State Disaster Relief Fund (SDRF) for Agricultural crops damages and sanction a sum of Rs.2,69,94,200/- Input subsidy under SDRF for Horticultural crops damages in Tiruvallur, Chengalpattu, Kancheepuram, Ranipet, Tiruvannamalai, Vellore and Villupuram Districts – Orders - Issued.

ORDER:

During the Northeast Monsoon 2023, the Cyclonic Storm "MICHAUNG" (Migjaum) over West central & adjoining Southwest Bay of Bengal off south Andhra Pradesh and adjoining north Tamil Nadu coasts moved northwestwards and intensified into a Severe Cyclonic Storm and passed near North Tamil Nadu coast on 04.12.2023 with a maximum sustained wind speed of 60-70 kmph gusting to 80 kmph and caused extremely heavy rainfall in Chennai, Tiruvallur, Kancheepuram and Chengalpattu Districts.

2. In the letter fourth read above, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has stated as follows: -

A. Agriculture

The Commissioner of Agriculture has requested to sanction a sum of Rs.45,43,61,546/- to extend SDRF input subsidy to 42,353 affected farmers whose agricultural crops were damaged in an area of 26,723.3380 ha due to Michaung cyclone 2023 in Chengalpattu, Kancheepuram, Tiruvallur, Ranipet, Tiruvannamalai, Vellore and Villupuram districts.

- 3. In this connection, the Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner has therefore recommended the proposals of the Commissioner of Agriculture and the Director of Horticulture as follows:
 - a) To sanction a sum of Rs. 45,43,61,545.01 under the Funding Window "Relief and Response" of State Disaster Response Fund (SDRF) towards input subsidy to the 42353 affected farmers whose Agricultural Crops were damaged in an extent of 26723.34 Ha due to Michaung Cyclone-2023 in Chengalpattu, Kancheepuram, Ranipet, Tiruvallur, Tiruvannamalai, Vellore and Villupuram Districts.
 - b) To sanction a sum of Rs. 2,69,94,200/- towards the input subsidy to the 4311 affected farmers whose Horticultural crops were damaged in an extent of 1452.344 Ha due to MICHAUNG Cyclone-2023 in Chengalpattu, Kancheepuram, Ranipet, Tiruvallur, Tiruvannamalai, Vellore and Villupuram Districts.
- 4. The Government after careful examination, accept the proposals of the Additional Chief Secretary / Commissioner of Revenue Administration and State Relief Commissioner and based on the approval of the above proposal in the State Executive Committee, hereby accord the following:
 - a) sanction a sum of Rs.45,43,61,545/- (Rupees Forty Five Crore Forty Three Lakh Sixty One Thousand Five Hundred and Forty Five Only) under the Funding Window "Relief and Response" of State Disaster Response Fund (SDRF) to the Commissioner of Agriculture towards

input subsidy to the 42353 affected farmers whose Agricultural Crops were damaged in an extent of 26723.34 Ha due to Michaung Cyclone-2023 in Chengalpattu, Kancheepuram, Ranipet, Tiruvallur, Tiruvannamalai, Vellore and Villupuram Districts.

- b) sanction a sum of Rs. 2,69,94,200/- (Rupees Two Crore Sixty Nine Lakh Ninety Four Thousand and Two Hundred Only) under the Funding Window "Relief and Response" of State Disaster Response Fund (SDRF) to the Director of Horticulture and Plantation Crops towards the input subsidy to the 4311 affected farmers whose Horticultural crops were damaged in an extent of 1452.344 Ha due to MICHAUNG Cyclone-2023 in Chengalpattu, Kancheepuram, Ranipet, Tiruvallur, Tiruvannamalai, Vellore and Villupuram Districts.
- 5. The amount Sanctioned in para 4 above shall be debited to the following heads of account: -

6. Necessary additional funds of Rs.48,13,55,745/- will be provided in Final Modified Appropriation 2023-2024. Pending provision of such funds, the Additional Chief Secretary / Commissioner of Revenue Administration and State Relief Commissioner is authorized to draw and disburse the amount. This expenditure should be brought to the notice of Legislative Assembly by the way of Specific Inclusion in the Supplementary Estimates 2023-2024. The Additional Chief Secretary/ Commissioner of Revenue Administration and State Relief Commissioner is directed to include the expenditure sanctioned above, while sending the Budget Proposal of Final Modified Appropriation 2023-2024 and also send necessary Explanatory Notes to Finance (Revenue) Department for including the above expenditure in the supplementary Estimates 2023-2024, without fail.
