WHEREAS the Principal Secretary/Commissioner of Revenue Administration in the letter seventh read above has stated that the Government of India, Ministry of Home Affairs in the letter sixth read above issued 5th Addendum to the guidelines and the addendum has been got reconciled with the Government orders second, third, fourth and fifth read above and sent the amendment proposal to the Notification issued in the Government order second read above read with Notification issued in the order third, fourth and fifth read above.

NOW THEREFORE the State Government of Tamil Nadu based on the proposal of Principal Secretary and Commissioner of Revenue Administration issues following amendment to the Notification issued in the order second cited read with Notification issued in the order third, fourth and fifth read above.

Addition of sub-clause (o) in exception to clause 4

(o) Operations of the fishing (marine) / aquaculture industry, including feeding & maintenance, harvesting, processing, packaging, cold chain, sale and marketing; hatcheries, feed plants, commercial aquaria, movement of fish/shrimp and fish products, fish seed/feed and workers for all these activities.
