NOTIFICATION

WHEREAS in the G.O. eighth read above the Government have extended the restrictions in the territorial jurisdictions of the State to contain the spread of COVID-19 upto 03.05.2020 to contain the spread of COVID-19 by adhering the following Consolidated Revised Guidelines stipulated by Government of India under the Disaster Management Act, 2005.

WHEREAS the Principal Secretary/Commissioner of Revenue Administration has stated that the Government of India, Ministry of Home Affairs in the order ninth read above has ordered to include the following in the Consolidated Revised Guidelines for strict implementation by State Government:

I. Sub-clause (viii) under Clause 6 'A' on All Agricultural and horticultural activities:

viii Collection, harvesting and processing of Minor Forest Produce (MFP)/Non Timber Forest Produce (NTFP) by Scheduled Tribes and other forest dwellers in forest areas.

II. Sub-clause (iii) under Clause 6 'C' on Plantations:

 Bamboo, Coconut, Arecanut, Cocoa, spices plantation and their harvesting, processing, packaging sale and marketing.

III. Sub-clause (v) & (vi) under Clause 7 on Financial Sector:

- v. Non-Banking financial institutions (NBFCs) including Housing Finance Campanies (HFCs) and Micro Finance Institutions (NBFC-MFIs) with bare minimum staff.
- vi. Cooperative Credit Societies.
- IV. Clause 16 (i) on construction activities in rural areas, includes, water supply and sanitation, laying/erection of power transmission lines and laying of telecom optical fiber and cable along with related activities.

NOW THEREFORE the State Government of Tamil Nadu based on the proposal of Principal Secretary and Commissioner of Revenue Administration ordered to include the following in the Consolidated Revised Guidelines for strict implementation.

- I. Sub-clause (viii) under Clause 6 'A' on All Agricultural and horticultural activities:
 - viii Collection, harvesting and processing of Minor Forest Produce (MFP)/Non Timber Forest Produce (NTFP) by Scheduled Tribes and other forest dwellers in forest areas.

II. Sub-clause (iii) under Clause 6 'C' on Plantations:

iii. Bamboo, Coconut, Arecanut, Cocoa, spices plantation and their harvesting, processing, packaging sale and marketing.

III. Sub-clause (v) & (vi) under Clause 7 on Financial Sector:

- v. Non-Banking financial institutions (NBFCs) including Housing Finance Campanies (HFCs) and Micro Finance Institutions (NBFC-MFIs) with bare minimum staff.
- vi. Cooperative Credit Societies.
- IV. Clause 16 (i) on construction activities in rural areas, includes, water supply and sanitation, laying/erection of power transmission lines and laying of telecom optical fiber and cable along with related activities.
