WHEREAS in the order fourth read above, the Government have extended the State-wide lockdown till 24:00 hrs of 30.6.2020 under the Disaster Management Act, 2005 with various relaxations ordered in GO.Ms.No.217, Revenue and Disaster Management (DM-II) Department, dated 3.5.2020 and GO.Ms.No.245, Revenue and Disaster Management (DM-II) Department, dated 18.5.2020 and amendments issued thereon with further guidelines and relaxations in the order fourth referred above.

NOW therefore based on the proposal of Principal Secretary/Commissioner of Revenue Administration, the Government issue the following amendment to GO.Ms.No.262, Revenue & Disaster Management (DM-II) Department, dated 31.5.2020:

A) The sub-clause viii under Clause I shall be replaced as

"All cinema halls, gymnasiums, swimming pools, entertainment parks, theatres, bars, auditoriums, assembly halls, **beaches**, **tourist places, zoological parks, museum and similar** **places of public gathering.** Sports complexes and stadia will be permitted to open without spectators".

B) The following paragraph in Annexure I is hereby deleted.

"Public transport carriers will charge 50% additional fare over and above existing fare for all type of operations temporarily to compensate loss due to operating at lesser seating capacity."
