ORDER:

In Government order 1 to 5th read above, the Government have issued orders with regard to the guidelines to be followed during lock down period in adherence to the notifications issued by Ministry of Home Affairs, Government of India from time to time.

2. In the G.O. 4th read above, the Government amongst others, have granted permission and exemptions for conduct of Standard 12 re-examination for the absentees of the examinations held on 24.03.2020 which was scheduled to be held on 18.06.2020 along with Standard Operating Procedure (SOP) for the conduct of the examinations. In the G.O. 6th read above, orders were issued that this re-examination already scheduled on 18.06.2020 would be held later.

3. Now the Government have decided to conduct the re-examination for the absentees of the examination held on 24.03.2020 of Standard 12 on 27.07.2020.

4. The Government accordingly, issue following guidelines to conduct the re-examination for standard 12 on 27.07.2020 for the absentees of the examination held on 24.03.2020.

- The re-examination for the absentees of the Standard 12 Board Examinations for the subjects Chemistry, Accountancy and Geography held on 24.03.2020 shall be held on 27.07.2020 in their respective schools. The private candidates shall write the re-examination in the respective Private Examination Centres where they wrote the earlier examinations for other subjects.
- The students writing the re-examination shall get the fresh hall tickets downloaded from their respective schools, and the private candidates shall get them downloaded from the respective private examination centres where they wrote the earlier examinations or directly download the hall tickets from the official website www.dge.tn.gov.in by entering their examination register number and date of birth.
- The Chief Educational Officer concerned shall arrange for required transport facilities for the needy candidates writing the re-examination on 27.07.2020.
- If any examination centre is located within the containment zone, a nearby school outside the containment zone shall be designated as Alternate Examination Centre.
- The students residing in containment zones shall be allowed to write the examinations in the respective examination centres to prevent their mingling with rest of the students.

- For all other guidelines, the Standard Operating Procedure and guidelines prescribed in G.O.(Ms) No.246, Revenue and Disaster Management (DM-II)Department dated 20.05.2020 shall be followed.
