read above, Now, therefore the WHEREAS in the order 20th Government of Tamil Nadu based on the review meetings held on various dates, particularly views expressed by the District Collectors in the meeting through Video Conference, based 22.6.2020 on Expert Committee constituted under the the recommendations of Chairmanship of Additional Chief Secretary, Finance Department on Exit Strategy and views expressed by the Medical Experts and Public Health Committee during the discussion with the Hon'ble Chief Minister on 29.6.2020 and in consultation with the Senior Ministers hereby order to extend the State-wide lockdown till 24:00 hrs of 31.07.2020 under the Disaster Management Act, 2005 with various relaxations ordered in G.O. Ms.No.217, Revenue and Disaster Management (DM II), Department, dated 3.5.2020 and G.O.Ms.No.245, Revenue and Disaster Management (DM II), Department, dated 18.5.2020 and amendments issued thereon with the existing restrictions.

The Principal Secretary and Commissioner of Administration has recommended amendment to the Government order 20th read above in respect of Operation of Buses during the lockdown period.

3. NOW THEREFORE the Government hereby issues the following amendment to the order 20th read above:

"Operation of Buses: Operation of both Private and Government buses within the districts will remain suspended from 1.7.2020 to 15.7.2020 throughout the State" shall be replaced as,

"Operation of Buses: Operation of both Private and Government buses within the districts will remain suspended from 1.7.2020 to 31.7.2020 throughout the State"
