4.The Government hereby accord permission to all the autonomous Colleges affiliated to the State Universities of Tamil Nadu referred in the Government Order second read above, to conduct final semester examinations for the year 2019-2020 during September, 2020 under Disaster Management Act 2005, duly following the Standard Operating Procedures.
