### **ORDER:**

In the letter read above, the Managing Director, Tamil Nadu Medical Services Corporation Limited has stated that Tamil Nadu Medical Services Corporation Limited continuously procuring and supplying all required drugs and medicines, Safety kits and protective consumables such as surgical face mask, N95 type face mask etc., to all the Government Medical institutions since March 2020 towards containment measure of Covid-19.

2. The Managing Director, Tamil Nadu Medical Services Corporation Limited has stated that, now Tamil Nadu Medical Services Corporation Limited has been entrusted with the task of procurement of syringes for conducting vaccination camps all over the state towards achievement of cent per cent vaccination to all eligible population and they have so far supplied 1.25 crores of syringes and they were committed to supply to an extent of another 7 crore syringes. He has also submitted the proposed procurement for next 90 days requirements of Consumables and syringes for vaccination as detailed below:-

3. The Managing Director, Tamil Nadu Medical Services Corporation Limited has requested to sanction of Rs.32.00 Crores under Chief Minister's Public Relief Fund (CMPRF) for procurement of the above consumables to meet the requirements upto 31.12.2021.

The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Medical Services Corporation Limited and based on the approval of the State Executive Committee, accord sanction a sum of Rs.32.00 Crore (Rupees Thirty Two Crore only) under Tamil Nadu State Disaster Management Authority Fund (TNSDMA) to the Managing Director, Tamil Nadu Medical Services Corporation Limited exclusively for procurement of Disposable Triple layer Mask, FFP2 consumables and Syringes for vaccination program for next 90 days.

5. The expenditure sanctioned in para (4) above shall be incurred from the funds under Tamil Nadu State Disaster Management Authority (TNSDMA).
