ORDER:

In the letter sixth read above, the Principal Secretary / Commissioner of Revenue Administration has stated that the Government of India by invoking the provisions of Disaster Management Act, 2005 have delegated the powers to the Secretary, Ministry of Health and Family Welfare, Government of India to enhance preparedness and containment of novel Corona Virus (COVID-19) and the other ancillary matters connected thereto and the National Disaster Management Authority has been requested to identify quarantine and isolation facilities across all the districts within the country and the Secretary, Health and Family Welfare Department, Government of Tamil Nadu has been requested to initiate necessary immediate action in this regard. Accordingly, the meeting of the Tamil Nadu State Disaster Management Authority was conducted by the Chairman, Tamil Nadu State Disaster Management Authority (TNSDMA) / Hon'ble Chief Minister of Tamil Nadu on 9th and 13th March 2020 to take stock of the situation prevailing due to the outbreak of Covid-19. During the above meeting, the Hon'ble Chief Minister of Tamil Nadu issued instructions to all the officials to take all possible preparedness / preventive measures to control the outbreak of Covid-19.

- 2. In the Press statement fifth read above, the Hon'ble Chief Minister, Tamil inadu has also announced that a sum of Rs.60.00 crores sanctioned to various Line Departments towards preparedness / preventive measures to contain the outbreak of Covid-19.
- 3. The Principal Secretary/ Commissioner of Revenue Administration has further stated that the Government of Tamil Nadu vide its Notification No.118, dated 14.03.2020, (G.O. (Ms) No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corono Virus Disease (COVID-19) as a notified disease in the State of Tamil Nadu and the Government of India, Ministry of Home Affairs (Disaster Management Division) Letter.No.33-4/2020/NDM-1, dated 14.3.2020, it has been informed that the Central Government keeping in view the spread of COVID-19 Virus in India and the declaration of COVID-19 as pandemic by the World Health Organization (WHO), by way of a special one time dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under State Disaster Response Fund (SDRF). The list of norms of assistance for containment of COVID-19 Virus in India, eligible from State Disaster Response Fund (SDRF) has also been communicated by Government of India.
- 4. The Principal Secretary/ Commissioner of Revenue Administration has further stated that in pursuant to the G.O. (Ms) No.380, Revenue [DM.3(2)] Department, dated 27.10.2015, G.O. (Ms) No.246, Revenue and Disaster Management [DM.3(2)] Department, dated 03.08.2017 and Government of India, Ministry of Home Affairs (Disaster Management Division) Letter No.33-4/2020/NDM-1, dated 14.3.2020, funds may be sanctioned under State Disaster Response Fund.
- 5. The Principal Secretary/ Commissioner of Revenue Administration has therefore requested the orders of Government to sanction a sum of Rs.60 crores (Rupees Sixty Crores only) from State Disaster Response Fund to the following Line Departments towards preparedness / preventive measures to contain the outbreak of Covid-19.

This expenditure should be brought to the notice of the Legislature by Direct Inclusion in the Supplementary Estimates 2019-2020. The Principal Secretary / Commissioner of Revenue Administration is also directed to include the expenditure sanctioned above, while sending the budget proposal for Final Modified Appropriation 2019-2020 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2019-2020 to Finance (Revenue) Department at appropriate time without fail.
- 9. The Principal Secretary / Commissioner of Revenue Administration is the estimating reconciliatory and controlling authority for the above new sub-head of account. The Treasury Officer / Pay and Accounts Officers concerned are requested to open the above new sub-head in the books.
