### **ORDER:**

In Government of India, Ministry of Home Affairs (Disaster Management Division) Lr. No.33-4/2020/NDM-1, dated 14.3.2020, it has been informed that the Central Government keeping in view the spread of COVID-19 Virus in India and the declaration of COVID-19 as pandemic by the World Health Organization (WHO), by way of a special onetime dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under SDRF. The list of norms of assistance for containment of COVID-19 Virus in India, eligible from SDRF has also been communicated by Government of India. The Government of Tamil Nadu vide its Notification No.118 dated 14.03.2020, (G.O.Ms.No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corona Virus Disease (COVID-19) as a notified disease in the State of

Tamil Nadu. Subsequently to prevent and contain the spread COVID-19 lockdown was imposed throughout the State through G.O 3<sup>rd</sup> and 4<sup>th</sup> cited and lastly extended till 17.05.2020.

2. The Principal Secretary/Commissioner of Revenue Administration has submitted that funds were sanctioned under State Disaster Response Fund to District Administration to carry out the preparedness / preventive measures to contain the outbreak of COVID-19. Further funds were also drawn under TR-27 by the District Collectors. The details of funds sanctioned, drawn under TR-27 and the expenditure incurred are as tabulated below. Now large number of labourers totaling 6984 from Koyambedu have returned to their native Districts as tabulated below. Some of them are infected by COVID-19 and hence the number of positive cases are in an increasing trend in the Districts.
