ORDER

In the Government order first read above, sanction was accorded for Rs.2.00 crore from State disaster Response Fund to the District Collector, Tiruvannamalai for the provision of temporary accommodation and food, clothing, medical care etc., for people affected and sheltered in quarantine camps, cost of disinfectants, cost of consumables for sample collections, support for checking, screening and contact tracing, purchase of masks and personal protection equipments to contain the outbreak of COVID-19.

- 2. In the letter third read above, the Principal Secretary/Commissioner of Revenue Administration has stated that the District Collector, Tiruvannamalai has informed that the funds allotted in G.O.(Ms).No.171, Revenue and Disaster Management (DM-II) Department, dated 24.03.2020 pertains to financial year 2019-20. It has been further stated that the funds could not be utilised due to the closure of financial year 2019-20 now and hence he has been requested to revalidate the sanctioned amount of Rs.2.00 Crore which was sanctioned earlier in the above government order.
- 3.The Principal Secretary and Commissioner of Revenue Administration has therefore requested orders of the Government to revalidate the G.O.Ms.No.171, Revenue and Disaster Management (DM-II) Department, dated 24.03.2020 and to sanction an amount of Rs.2.00 Crore to the District Collector of Tiruvannamalai.

- 4. The Government after careful examination accept the proposal of the Principal Secretary/ Commissioner of Revenue Administration and based on the approval of State Executive Committee authorise Principal Secretary/Commissioner of Revenue Administration to release an amount of Rs.2.00 crore (Rupees Two crore only) from State Disaster Response Fund (SDRF) (sanctioned in the Government order first read above) to the District Collector, Tiruvannamalai District for provision of temporary accommodation and food, clothing, medical care etc., for people affected and sheltered in quarantine camps, cost of disinfectants, cost of consumables for sample collections, support for checking, screening and contact tracing, purchase of masks and personal protection equipments to contain the outbreak of Covid-19 (The sanction is from SDRF and not under TR 27)
- 5. The expenditure sanctioned in Para 4 above shall be debited to the following head of account :-
 - 2245 Relief on Account of Natural Calamities-80-General 800 Other expenditure State's Expenditure-AH-Disaster Preparedness / Preventive measures to contain the outbreak of Corona Virus (Covid 19) 309 Grants-in-Aid 09 Others

- 6. Necessary additional funds will be provided in RE/FMA 2020-21. Pending provision of such funds, the Principal Secretary/ Commissioner of Revenue Administration is authorized to draw and disburse the amount. The expenditure shall be brought to the notice of Legislature by specific inclusion in Supplementary Estimate 2020-21. The Principal Secretary/ Commissioner of Revenue Administration is requested to send necessary proposal for inclusion of this expenditure in Revised Estimate 2020-21 and also send necessary draft explanatory note for specific inclusion in the Supplementary Estimate 2020-21 to Finance (BG-I/Revenue) Department without fail at an appropriate time.
- 7. This order issues with the concurrence of Finance Department vide its UO.No.256/DS(B)/Revenue/2020,dated: 30.05.2020 with additional sanction ledger No.0096 (Ninety Six)
