Disaster Management – Lock down declared up to 30.06.2020 due to outbreak of COVID –19 – Sanction an amount of Rs.14,63,68,000/- from State Disaster Response Fund to unregistered weavers and Rs.2,48,46,000/- from State Disaster Response Fund to 12,423 registered workers of Tamil Nadu Street vending shops & Establishments workers welfare board - Orders- Issued.

#### **ORDER:**

In the Government of India, Ministry of Home Affairs (Disaster Management Division) Lr.No.33-4/2020/NDM-1, dated 14.3.2020, it has been informed that the Central Government keeping in view the spread of COVID-19 Virus in India and the declaration of COVID-19 as pandemic by the World Health Organization (WHO), by way of a special onetime dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under SDRF. The list of norms of assistance for containment of COVID-19 Virus in India, eligible from SDRF has also been communicated by Government of India vide it's Letter No.S 33-4 / 2020 –

NDM-I Dated: 14.03.2020 and 28.03.2020. The Government of Tamil Nadu vide its Notification No.118 dated 14.03.2020, (G.O.Ms.No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corona Virus Disease (COVID-19) as a notified disease in the State of Tamil Nadu.

2. The Principal Secretary/ Commissioner of Revenue Administration has stated that the Additional Secretary to Government, Labour and Employment Department has informed that, the Government in their order fifth cited have issued orders to sanction an amount of Rs.2,48,46,000/- from SDRF disbursement of financial assistance of Rs.1000/- for two spells to the remaining 12,423 registered workers of Tamil Nadu Street vending shops & Establishments workers welfare board (12,423 X 2000) as detailed below:

Hence, the Additional Secretary to Government, Labour and Employment Department has requested to include the above expenditure under SDRF.

3. The Hon'ble Chief Minister of Tamil Nadu in his announcement dated: 20.05.2020 has announced that:

“கைத்தறி மற்றும் கைத்தறி பட்டு நெசவுத் தொழிலில் ஈடுபட்டுள்ள பதிவு பெறாத நெசவாளர்களுக்கும் நிவாரணத் தொகை வழங்க அரசு முடிவு செய்துள்ளது. அதன்படி, தமிழ்நாடு முழுவதிலும் உள்ள கைத்தறி மற்றும் கைத்தறி பட்டு நெய்யும் நெசவாளர்களின் பட்டியல், விலையில்லா 200 யூனிட் மின்சாரம் பெற்று பயன்பெறும் நெசவாளர்களின் பட்டியலுடன் ஒத்திசைவு செய்யப்பட்டு, அதன் அடிப்படையில், ஏற்கனவே வழங்கப்பட்டுள்ள உதவியைப் பெற்ற பட்டியலில் விடுபட்டுள்ள நெசவாளர்களின் பட்டியல் தயாரிக்கப்பட்டு, ஊராட்சி கால நிவாரணத் தொகையான ரூ.2,000/- வழங்க கைத்தறித் துறை இயக்குநர் அவர்கள் மூலமாக நடவடிக்கை எடுக்க உத்தரவிடப்பட்டுள்ளது. இதற்கான விரிவான வழிகாட்டி நெறிமுறைகளை கைத்தறி மற்றும் துணிநூல் துறை இயக்குநர் வழங்குவார். அதன்படி, தகுதியான நெசவாளர்கள் அந்தந்த மாவட்டங்களில் உள்ள கைத்தறி மற்றும் துணிநூல் துறைக்கு விண்ணப்பம் செய்து பயனடையுமாறு கேட்டுக் கொள்ளப்படுகிறது”.

Hence, he has requested to sanction an amount of Rs.14,63,68,000/- (Rupees Fourteen crore sixty three lakhs and sixty eight thousand only) under SDRF to provide Rs.2,000/- each to 73184 un-registered weavers in the state.

5. The Principal Secretary/ Commissioner of Revenue Administration as also stated that the above Proposals were examined and it is found eligible as per MHA, GOI letter No.33-4/2020-NDM-I dated 14.03.2020 and 28.03.2020.

6. The Principal Secretary/ Commissioner of Revenue Administration has therefore requested orders of the Government to sanction an amount of Rs.14,63,68,000/- (Rupees Fourteen crore sixty three lakhs and sixty eight thousand only) from State Disaster Response Fund (SDRF) to provide Rs.2,000/- each to 73184 un-registered weavers in the state and sanction an amount of Rs.2,48,46,000/- (Rupees Two crore forty eight lakh and forty six thousand only) from State Disaster Response Fund (SDRF) to disbursement of financial assistance of Rs.1000/- for two spells to the remaining 12,423 registered workers of Tamil Nadu Street vending and shops & Establishments workers welfare board.

7. The Government after careful examination, accept the proposal of the proposal of the Principal Secretary/ Commissioner of Revenue Administration and



accord to sanction an amount of Rs.14,63,68,000/- (Rupees Fourteen crore sixty three lakhs and sixty eight thousand only) from State Disaster Response Fund (SDRF) to provide Rs.2,000/- each to 73184 un-registered weavers in the state and sanction an amount of Rs.2,48,46,000/-(Rupees Two crore forty eight lakh and forty six thousand only) from State Disaster Response Fund (SDRF) to disbursement of financial assistance of Rs.1000/- for two spells to the remaining 12,423 registered workers of Tamil Nadu Street vending and shops & Establishments workers welfare board.

8. The expenditure sanctioned in Para 7 above shall be debited to the following head of account :-

9. Necessary additional funds will be provided in RE/FMA 2020-21. Pending provision of such funds, the Principal Secretary/ Commissioner of Revenue Administration is authorized to draw and disburse the amount of Rs.17,12,14,000/- The expenditure shall be brought to the notice of Legislature by specific inclusion in Supplementary Estimate 2020-21. The Principal Secretary/ Commissioner of Revenue Administration is requested to send necessary proposal for inclusion of this expenditure in Revised Estimate 2020-21 and also send necessary draft explanatory note for specific inclusion in the Supplementary Estimate 2020-21 to Finance (BG-I/Revenue) Department without fail at an appropriate time.
