ORDER:

In the Government of India, Ministry of Home Affairs (Disaster Management Division) Letter No.33-4/2020/NDM-1, dated 14.3.2020, it has been informed that the Central Government keeping in view the spread of COVID-19 Virus in India and the declaration of COVID-19 as pandemic by the World Health Organization (WHO),

by way of a special onetime dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under SDRF. The list of norms of assistance for containment of COVID-19 Virus in India, eligible from SDRF has also been communicated by Government of India vide it's Letter Nos. 33-4 / 2020 – NDM-I Dated: 14.03.2020 and 28.03.2020. The Government of Tamil Nadu vide its Notification No.118 dated 14.03.2020, (G.O.Ms.No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corona Virus Disease (COVID-19) as a notified disease in the State of Tamil Nadu.

2. The Principal Secretary / Commissioner of Revenue Administration in his letter dated 08.06.2020 has stated that, the Commissioner, Greater Chennai Corporation has requested Rs.360.766 crore towards containment of COVID-19 to be incurred till August 2020 as detailed below:-

- 6. The Principal Secretary / Commissioner of Revenue Administration has further stated that all these proposals are examined with provisions of SDRF and fund eligible. Hence, he has recommended all the proposals and requested to sanction Rs.10.00 crore initially under SDRF to the Commissioner, Greater Chennal Corporation towards COVID-19 containment measures subject to getting additional information for certain other needs, Rs.9.08 Crore to the Director of Public Health and Preventive Medicine towards the purchase of Corona Care Drug Kits, Rs.2.0 Crores to the Collector, Tiruvallur District to meet the expenditure incurred for providing food, basic amenities and transportation, operation of relief camps etc., for migrant labourers and Rs.0.351 Crores to the Managing Director, Tamil Nadu Medical Service Corporation towards purchase instruments etc., for the equipment of COVID Care centre at ESI Hospital Ayanavaram from the State Disaster Response Fund (SDRF).
- 7. The Government after careful examination, accept the proposal of the Principal Secretary / Commissioner of Revenue Administration to sanction Rs.10.00 crore initially under SDRF to the Commissioner, Greater Chennai Corporation towards COVID-19 containment measures subject to getting additional information for certain other needs, Rs.9.08 Crore to the Director of Public Health and Preventive Medicine towards the purchase of Corona Care Drug Kits, Rs.2.0 Crores to the Collector, Tiruvallur District to meet the expenditure incurred for providing food, basic amenities and transportation, operation of relief camps etc., for migrant labourers and Rs.0.351 Crores to the Managing Director, Tamil Nadu Medical Service Corporation towards purchase instruments etc., for the equipment of COVID -19 Care centre at ESI Hospital Ayanavaram from the State Disaster Response Fund (SDRF) and Issue orders accordingly.
- 8. The amount sanctioned in Para 7 above shall be debited to the following head of account:-

2245 – Relief on Account of Natural Calamities – 80 General – 800 Other expenditure State's Expenditure – AH Disaster Preparedness / Preventive measures to contain the outbreak of Corona Virus (Covid 19) – 309 Grants-in-Aid – 09- Others.

Necessary additional funds of Rs.21,43,10,000/- will be provided in Revised EstImates/Final Modified Appropriation 2020-2021 Pending provision of such funds, the Principal Secretary/Commissioner of Revenue Administration is authorized to draw and disburse the amount. The Expenditure shall be brought to the notice of Legislative Assembly by Specific inclusion in the Supplementary Estimates 2020-2021. The Principal Secretary/Commissioner of Revenue Administration is requested to send necessary proposal for inclusion of this expenditure in Revised Estimate 2020-2021 and also send necessary Explanatory Notes for inclusion of this expenditure in the supplementary Estimates 2020-2021 at appropriate time.
