ORDER:

In the letter fourth read above, the Principal Secretary / Commissioner of Revenue Administration has stated that the Government of Tamil Nadu has issued Gazette Notification declaring that the Corona Virus Diseases (COVID -19) is a notified disease in State of Tamil Nadu. The Government has announced complete lockdown of activities except essential services in the State of Tamil Nadu till 30.6.2020. The Hon'ble Chief Minister of Tamil Nadu has announced that considering the livelihood of the Differently Abled persons during the lock down period, a cash assistance of Rs.1000/- will be sanctioned to all 13.35 Lakhs National Identity and Disability Certificate holders (NIDC) in Tamil Nadu.

- 2. The Principal Secretary / Commissioner of Revenue Administration also stated that, the Director for the Welfare of Differently Abled / State Commissioner for Persons with Disabilities has stated as follows:-
 - To implement the announcement of the Hon'ble Chief Minister, a sum of Rs.133,52,19,000/- will be required.

- The District Collectors of respective Districts may be appointed as the Nodal Officer for the distribution of funds.
- The guidelines for distribution of a Cash Assistance for Differently Abled Persons will be issued by the Director for the Welfare of the Differently Abled.

The Director for the Welfare of Differently Abled / State Commissioner for Persons with Disabilities has requested to sanction a sum of Rs.133,52,19,000/- (Rupees One hundred and thirty three crores fifty two lakhs and nineteen thousand only) to District collectors from the State Disaster Response Fund(SDRF).

- 3. The Principal Secretary / Commissioner of Revenue Administration has further stated that in pursuant to the G.O. Ms.No.380, Revenue Department, dated 27.10.2015, G.O.Ms.No.246, Revenue Department, dated 03.08.2017 and Government of India, Ministry of Home Affairs (Disaster Management Division) Letter No.33-4/2020/NDM-1, dated 14.3.2020 and 28.03.2020, in view of urgency a sum of Rs.133,52,19,000/- (Rupees One Hundred and Thirty Three Crores Fifty Two Lakhs and Nineteen Thousand only) may be sanctioned to the District Collectors from the State Disaster Response Fund (SDRF), for distribution of a Cash Assistance of Rs.1000/- each for National Identity and Disability Certificate holders (NIDC), as recommended by the Director for the Welfare of Differently Abled / State Commissioner for Persons with Disabilities.
- 4. The Principal Secretary / Commissioner of Revenue Administration has recommended the proposal of the Director for the Welfare of Differently Abled / State Commissioner for Persons with Disabilities and requested to sanction a sum of Rs.133,52,19,000/- (Rupees One Hundred and Thirty Three Crores Fifty Two Lakhs and Nineteen Thousand only) to the District Collectors from the State Disaster Response Fund (SDRF), for distribution of Cash Assistance of Rs.1000/- each for National Identity and Disability Certificate holders (NIDC), as recommended by the Director for the Welfare of Differently Abled / State Commissioner for Persons with Disabilities.
- 5. The Government after careful consideration of the proposal of the Principal Secretary / Commissioner of Revenue Administration and approval of the State Executive Committee, accord sanction for a sum of Rs.133,52,19,000/- (Rupees One Hundred and Thirty Three Crores Fifty Two Lakhs and Nineteen Thousand only) to the District Collectors from the State Disaster Response Fund (SDRF) for distribution of Cash Assistance of Rs.1000/- each for National Identity and Disability Certificate holders (NIDC) as detailed below:-
