ORDER:

In the Government of India, Ministry of Home Affairs (Disaster Management Division) Lr.No.33-4/2020/NDM-1, dated 14.3.2020, it has been informed that the Central Government keeping in view of the spread of COVID-19 Virus in India and the declaration of COVID-19 as pandemic by the World Health Organization (WHO), by way of a special onetime

dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under SDRF. The list of norms of assistance for containment of COVID-19 Virus in India, eligible from SDRF has also been communicated by Government of India vide it's Letter No.s 33-4 / 2020 – NDM-I, dated: 14.03.2020 and 28.03.2020. The Government of Tamil Nadu vide its Notification No.118, dated 14.03.2020, (G.O.Ms.No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corona Virus Disease (COVID-19) as a notified disease in the State of Tamil Nadu.

2. In the letter 8th read above, the Principal Secretary and Commissioner of Revenue Administration has stated that the Director of Indian Medicine and Homoeopathy, the Director General of Police / Inspector General of Prisons, the District Collectors of Virudhunagar and Tenkasi has sent proposals seeking financial assistance under State Disaster Response Fund towards various activities relates to COVID-19 as detailed below:

In the above amount, proposals were sent to Government to sanction Rs.11,02,41,171 to the Director General of Prison, the Director of Indian Medicine and Homeopathy, the Collector, Virudhunagar and the Collector, Tenkasi.

- The Principal Secretary and Commissioner of Revenue Administration has further stated as follows:
 - a. The Director General of Police / Inspector General of Prisons in his letter has stated that various preventive measures are being taken by the Prison department including earmarking separate District /Sub Jails/Borstal Schools for admission of new prisoners to prevent the spreading of Covid-19 in prisons. The personnel are performing their duty round the clock despite the threat of this pandemic Covid-19. The number of prison personnel working as on 31.05.2020 is 4551 and requested to sanction a sum of Rs.3,07,25,254.00 (Rupees Three Crore Seven lakh Twenty Five Thousand Two Hundred and Fifty four only) for the purchase of Sanitary / Disinfectant / essential materials to maintain the cleanliness in prison premises and to avoid spreading of pandemic inside the prison premises. The Prison Department may examine possibility and producing Sanitary / Disinfectant / essential materials in house. Hence, the request of the Prison Department may be deferred for the time being.
 - b. The Director of Indian Medicine and Homoeopathy has stated that Directorate of Indian Medicine and Homoeopathy is implementing the Special Programme "AAROKYAM" as ordered in the Government Order G.O.Ms.No.201, Health & Family Welfare Department, Dated 23.04.2020 by distributing the Kabasura Kudineer / Natural Immune Boosting Powder and other AYUSH System of Interventions all over Tamil Nadu. The Government in G.O.Ms.No.216, Revenue and Disaster Management (DM-II) Department, Dated 02.05.2020 have sanctioned Rs.5.00 Crore to their Department for preparation of Nilavembu Kudineer and Kudineer Chooranam and other AYUSH Kabasura safety measures. including material for intervention Department has paid Rs.4.00 Crore for the Kabasura Kudineer and Rs.1.00 Crore for the Natural Immune Boosting Powder. The

Directorate of Indian Medicine and Homoeopathy is distributing these Powders to all Medical College Hospitals, District Head-quarters Hospitals, Taluk Hospitals and other COVID Care Hospitals / Centres functioning all over Tamil Nadu. This powder is also supplied to the Departments like Police, Revenue, Health Care Providers and all other ISM Wings etc., working under Government of Tamil Nadu. The total quantities of medicines produced at Alanthur TAMPCOL Factory from 01.04.2020 to 30.06.2020 are submitted as follows:

The above medicines are exclusively supplied for COVID relief at free of cost without any charge. The above rate is fixed on cost of the Raw Materials procured, Labour cost, Transportation, Packing etc., by the Committee of the TAMPCOL, Government of Tamil Nadu. The TAMPCOL is purchasing the raw material through Co-operative agency on Loan basis and requested that he has to settle the bill immediately, so that further production will continue smoothly without any hindrance. The Director of Indian Medicine and Homoeopathy has requested to sanction Rs.12,94,45,943/- to settle the due amount and further manufacturing of medicines smoothly. The request of the Director of Indian Medicine to

sanction Rs.12,94,45,943/- to settle the due amount and further manufacturing of medicines smoothly may be restricted to Rs.2.5 Crores

- (b) The Collector, Tenkasi has requested Rs.3,00,00,000/towards Transportation of Government employees, Providing feeding charges, accommodation in quarantine facility centers, Disinfection facilities. The Government in G.O Ms No. 322 Revenue and Disaster Management, Wing, DM II Section, Dated: 27.06.2020 have sanctioned Rs.1.50 Crores towards expenses for quarantine of incoming persons through trains and providing food and transporting to their native places and Disinfection activities towards the containment of COVID-19. Hence, this request may be considered later.

Revised Estimate 2020-21 and also send necessary draft explanatory note for specific inclusion in the Supplementary Estimate 2020-21 to Finance (BG-I/Revenue) Department without fail at an appropriate time.
