ORDER:

In the letter first read above, the Government of India, Ministry of Home Affairs (Disaster Management Division) has been informed that the Central Government keeping in view the spread of COVID-19 in India and the declaration of COVID-19 a pandemic by the World Health Organization

(WHO), by way of a special onetime dispensation, has decided to treat it as a notified disaster for the purpose of providing assistance under SDRF and the list of norms of assistance for containment of COVID-19 in India, eligible from SDRF has also been communicated by Government of India. The Government of Tamil Nadu vide its Notification No.118 dated 14.03.2020, (G.O.Ms.No.95, Health and Family Welfare (P1) Department, dated 13.3.2020) have declared that Corona Virus Disease (COVID-19) as a notified disease in the State of Tamil Nadu.

2. In the letter sixth read above, the Principal Secretary / Commissioner of Revenue Administration has stated that Proposals are being received from the District Collectors requesting funds fund for the expenditure towards the Institutional Quarantine of Passengers, Accommodating asymptomatic positive patients in Covid Care Centre and creation of new Covid Care Centres. The Principal Secretary / Commissioner of Revenue Administration has also stated that in view of increasing number of COVID-19 positive patients in the Districts, recognizing the critical necessity of funds without delay, he has requested to sanction Rupees 2 crore to each of the 36 District Collectors (Except Chennai) (Total Rs.72 crores) for the expenditure towards the Institutional Quarantine of Passengers, accommodating asymptomatic positive patients in Covid Care Centre and creation of new Covid Care Centres the expenditure norms already communicated will be considered as outer limit. Collectors shall exercise prudence in expanding the facilities duly considering the existing capacity, utilization of the existing capacity and the need to expand the same.

3. However on further consultation in the letter seventh read above, the Principal Secretary/Commissioner of Revenue Administration has revised the sanction of Rs.3 crores for districts which have more than 3000 active cases as on 21.7.2020 and Rs.2 crores for districts which have between 1000 and 2000 active cases as on 21.7.2020 and Rs.1 crore for remaining districts except Greater Chennai Corporation for expenditure towards the Institutional Quarantine of passengers creating of Covid Care Centre and screening cost of housing patients in Covid Care Centers. The Principal Secretary/Commissioner of Revenue Administration has therefore recommended to sanction the funds under State Disaster Response Funds as detailed below:-

4. The Government after careful examination, accept the proposal of the Principal Secretary / Commissioner of Revenue Administration and based on the approval of the State Executive Committee, accord **sanction for a sum of Rs.69 Crore (Rupees Sixty Nine crore only) from the Tamil Nadu State Disaster Management Authority (TNSDMA)** to the following District Collectors (Except Greater Chennai District) towards the Institutional Quarantine of Passengers, accommodating asymptomatic positive patients in Covid Care Centre and creation of new Covid Care Centre as detailed below: -

The Government also direct that the amount is sanctioned as an advance imprest amount to Collectors which is to be recouped by submission of details of expenditure to Principal Secretary/Commissioner of Revenue Administration for the release of the next installment on the following terms:-

- (a) Recoupment shall be permitted once 50% of the sanctioned imprest amount has been exhausted.
- (b) The expenditure should be on clearly specified eligible items; viz.
 - i) Institutional quarantine of passenger.
 - ii) Creation of Covid Care Centres.
 - iii) Recurring cost of housing patients in Covid Care Centres.
- (c) These expenditure should be incurred at the rates already approved by Principal Secretary/Commissioner of Revenue Administration as detailed in the Annexure.
- (d) The funds sanctioned in this order are not intended for purposes of disinfection, purchase of PPEs or civil works in hospitals/PHCs and other health care facilities.

5. The amount sanctioned in paragraph 4 above shall be met out from the Tamil Nadu State Disaster Management Authority Funds as ordered in the Government Order fourth read above.

6. This order issues with the concurrence of Finance Department vide its U.O.No.295/DS(B), Finance (Revenue) Department, dated: 27.07.2020.
