2. Subsequently, in the G.O. second read above, Standard Operating Procedures were issued for conducting examination in Government/Private ITIs and Industrial Schools.

In the letter third read above, the Director of Employment and Training has now proposed to conduct online classes for six days per week and online demonstration classes in lieu of practical training from the date of issue of the Government Order and to continue with the online examinations for the trainees in Government / Private ITIs by following SOP prescribed in the G.O, second read above, as per the schedule issued by Directorate General of Training, Ministry of Skill Development and Entrepreneurship, Government of India, till 10.04.2021

Accordingly, the Government hereby orders to conduct online classes for six days per week and online demonstration classes in lieu of practical training from the date of issue of this Order and to follow the Standard Operating Procedures issued in the G.O. second read above, to continue with the online examinations for the trainees in Government /

Private ITIs as per the schedule issued by Directorate General of Training, Ministry of Skill Development and Entrepreneurship, Government of India, till 10.04.2021.
