ORDER

Accordingly, in G.O. 5th read above, all Government and Government attached Institutions and Self-financing Deemed Universities running Medical and Paramedical undergraduate courses namely MBBS/ BDS/ Pharmacy /Nursing/ Paramedical have been permitted to conduct online classes until further orders.

The Director of Indian Medicine and Homoeopathy has opined that in view of the rising COVID cases and to prevent any occurrence of any clusters in Government and Government attached Institutions and self-financing Colleges conducting AYUSH Medical and Para Medical courses in their colleges and having hostels, as a precautionary and preventive measure, the students studying from the first to the pre-final years, studying various undergraduate AYUSH courses namely BSMS,

BAMS, BUMS and BNYS and Diploma in Nursing Therapy, Diploma in Integrated Pharmacy Courses, the ongoing campus classes can be conducted online until further orders.

In case of any ongoing examinations / practical examinations and those involving external examiners which have already being schedule and being conducted by any of these institutions, those may be completed by 31.03.2021 without cancellation by strictly following the Corona appropriate behavior and Standard Operating Procedures. The Hostels for the Final year students under all Under Graduate courses/CRRI/Post Graduate students would continue to function.

The Government after careful examination of the prevailing situation hereby directs that the Government and Government attached institutions and self-financing Deemed Universities running AYUSH and Paramedical courses in their Colleges, and having hostels, as a precautionary and preventive measure, the students studying from the first to the pre-final years, studying various undergraduate courses namely BSMS, BAMS, BUMS and BNYS and Diploma in Nursing Therapy, Diploma in Integrated Pharmacy Courses, the ongoing campus classes can be conducted online until further orders. In case of any ongoing examinations / practical examinations and those involving external examiners has already being scheduled and being conducted by any of these institutions those may be completed by 31.03.2021 without cancellation by strictly following the Corona appropriate behavior and Standard Operating Procedures. The Hostels for the Final Year students under all Under Graduate Courses / CRRI / Post Graduate Students would continue to function.
