ORDER:

In the reference 4th read above, the Additional Chief Secretary/ Commissioner of Revenue Administration has stated that the in the reference 1st read above the Government have sanctioned a sum of Rs.398.4479 crore from State Disaster Response Fund (SDRF) towards the relief and rescue work for the extensive damages caused due to heavy flood during North East Monsoon 2015, to various line departments/ District Rs.25.2181444 crore was sanctioned to the District Collectors towards the expenditure incurred in setting up of relief camps for accommodating the floodaffected people and for providing basic amenities namely, drinking water, sanitation facilities, providing bed sheets etc., to the flood affected people who were accommodated in the relief camps. Out of this, a sum of Rs.2,14,43,250/to Cuddalore District, was sanctioned for providing bed sheets to the floodaffected victims.

2. The Additional Chief Secretary/ Commissioner of Revenue Administration has further stated that the District Collector, Cuddalore has reported that, out of the sum of Rs.2,14,43,250/- an amount of Rs.1,85,84,150/- was paid to Co-optex towards the supply of 65,000 numbers of bed sheets issued to the flood affected victims, who were accommodated in relief camps. An amount of Rs.28,59,100/- out of the total amount of Rs.35,00,600/- due to Tamil Nadu Khadi Board, was paid to the Tamil Nadu Khadi Board towards supply of 10,000 numbers of bed sheets issued to the flood affected victims, who were accommodated in the relief camps. The

Additional Chief Secretary/ Commissioner of Revenue Administration has therefore requested to allot additional funds, for settlement of the balance amount of Rs.6,41,500/- to the Tamil Nadu Khadi Board.

- 3. The Additional Chief Secretary/ Commissioner of Revenue Administration has also stated that in the Government order 2nd read above, the Government have sanctioned Rs.6,41,500/- from Stated Disaster Response Fund (SDRF) to the District Collector, Cuddalore, for settlement of balance amount to the Tamil Nadu Khadi Board towards the supply of 10,000 number bed sheets to the flood-affected people who were accommodated in relief camps during the floods of North East Monsoon 2015. Based on the above Government order the District Collector, Cuddalore was authorized by the Additional Chief Secretary/Commissioner of Revenue Administration to draw and disburse the above sanctioned amount, after the end of the financial year 2016-2017. Therefore the District Collector, Cuddalore was unable to draw the said amount as the financial year had ended. Hence the District Collector, Cuddalore has requested to sanction a sum of Rs.6,41,500/- for the settlement of balance amount due to the Tamil Nadu Khadi Board.
- 4. The Additional Chief Secretary/ Commissioner of Revenue Administration has therefore requested to sanction a sum of Rs.6,41,500/-(Rupees six lakhs forty one thousand and five hundred only) from the State Disaster Response Fund (SDRF) to the District Collector Cuddalore for settlement of balance amount to the Tamil Nadu Khadi Board towards the supply of 10000 number bed sheets to the flood affected people who were accommodated in relief camps during the floods of North East Monsoon 2015.
- 5. The Government after careful consideration, accept the Proposal of the Additional Chief Secretary/ Commissioner of Revenue Administration and based on the approval of the State Executive Committee, accord sanction for a sum of Rs.6,41,500/- (Rupees six lakhs forty one thousand and five hundred only) from the State Disaster Response Fund (SDRF) to the District Collector, Cuddalore, for settlement of balance amount to the Tamil Nadu Khadi Board towards the supply of 10,000 number of bedsheets to the flood affected people who were accommodated in relief camps during the floods of North East Monsoon 2015
- 6. The amount sanctioned in paragraph 5 above shall be debited to the following head of account:-

"2245 Relief on account of Natural Calamities — 02 Flood, Cyclones etc. - 101 Gratuitous Relief — State's Expenditure - AB Distribution of free supply of Rice, Cloth, Food, Kerosene etc. in flood affected areas - 324 Materials and Supplies — 01 Materials and Supplies".

- 7. Necessary additional funds of Rs.6,41,500/- will be provided in FMA 2020-2021. Pending provision of such funds, the Additional Chief Secretary/Commissioner of Revenue Administration is authorized to draw and disburse the amount sanctioned above. The Additional Chief Secretary/ Commissioner of Revenue Administration is requested to include this item of expenditure while sending the budget proposal of FMA 2020-2021 to Government in Finance (Revenue) department at the appropriate time without fail.
- 8. This order issues with the concurrence of Finance Department vide its U.O. No. 49741/Finance (Revenue)/2020, dated 11.01.2021 with A.S.L.No.1392 (One thousand three hundred and ninety two)
