ORDER:

In the letter fourth read above the Principal Secretary/Commissioner of Revenue Administration has stated that the Director of Fisheries has requested administrative and financial sanction for an amount of Rs.18,10,000/- for the damages caused to the Fishing boats of Mandapam region in Ramanathapuram under State Disaster Response Fund (SDRF). The above proposal of the Director of Fisheries has been recommended to Government and requested to sanction a sum of Rs.18,10,000/- from the State Disaster Response Fund towards relief assistance to the damaged Mechanized Fishing Boats due to heavy wind and wave action in Mandapam area on 01.12.2019.

- 2. In the Government order second read above, the Government have sanctioned an amount of Rs.18,10,000/-(Rupees Eighteen Lakh and Ten Thousand only) from the State Disaster Response Fund (SDRF) towards relief assistance to the damaged Mechanized Fishing Boats affected due to heavy wind wave action in Mandapam area of Ramanthapuram District on 01.12.2019.
- 3. The Principal Secretary/Commissioner of Revenue Administration has further stated that in his proceedings, dated 24.03.2020 the Director of Fisheries has been authorized to draw and disburse the amount of Rs.18,10,000/- towards relief assistance to the damaged Mechanized Fishing Boats. However, the Director of Fisheries in his letter, dated 08.05.2020 has informed that due to Nationwide lockdown declared by Government on account of COVID-19 pandemic, the bill could not be presented to the Pay and Accounts Officer and that the said amount could not be drawn within the time limit of

financial year 2019-2020 and has requested to revalidate the sanctioned amount of Rs.18,10,000/- from under the State Disaster Response Fund (SDRF) provided to the Fisheries Department towards relief assistance to the damaged Mechanized Fishing Boats due to the said incidence during 2019-2020 and accord necessary orders for availing the funds during 2020-2021.

- 4. The Principal Secretary/Commissioner of Revenue Administration has therefore requested the Government to revalidate the G.O.(Ms)No.150 Revenue and Disaster Management Department, Disaster Management Wing, D.M.II Section, dated: 17.03.2020 in which the Government have sanctioned an amount Rs.18,10,000/- from the State Disaster Response Fund (SDRF) towards relief assistance to the damaged Mechanized Fishing Boats.
- 5. The Government, after careful consideration of the proposal of the Principal Secretary/ Commissioner of Revenue Administration and based on the approval of the State Executive Committee hereby revalidate the Government order second read above and authorise the Principal Secretary/Commissioner of Revenue Administration to utilize the unspent amount of Rs.18,10,000/-(Rupees Eighteen Lakh and Ten Thousand only) from the State Disaster Response Fund (SDRF) towards relief assistance to the damaged Mechanized Fishing Boats during 2020-2021.
- 6. The amount sanctioned in Para 5 above shall be debited to the following head of account:-

"2245 Relief on account of Natural Calamities - 02 Flood, Cyclones etc., - 118 Assistance for repairs /replacement of damaged boats and Equipment for Fishing - State's Expenditure - AA Relief Measures to Fishermen - 351 Compensation - 02 Other Compensations - voted.

- 7. Necessary additional funds of Rs.18,10,000/- will be provided in RE/FMA 2020-2021. Pending provision of such funds, the Principal Secretary/Commissioner of Revenue Administration is authorized to draw and disburse the amount. The expenditure shall be brought to the notice of Legislative Assembly by Specific inclusion in the Supplementary Estimates 2020-2021. The Principal Secretary/Commissioner of Revenue Administration is requested to sent necessary proposal for inclusion on the expenditure in Revised Estimate 2020-2021 and also to send necessary draft Explanatory Note for specific inclusion in the supplementary Estimate 2020-2021 to Finance (BG-I/Revenue) Department without fail at appropriate time.
