Order:

In the reference 3rd read above, the Principal Secretary/ Commissioner of Revenue Administration has stated that the average annual rainfall in Villupuram District during 2019 was 1046 mm with the highest rainfall of 222 mm during October 2019. During November and December 2019, the average rainfall received was 216 mm and 110 mm respectively. Similarly during the 2019 South West Monsoon (June to September), Villupuram District received an average rainfall of 45mm, 80mm, 149mm and 135mm respectively. The above rainfall during the South West Monsoon 2019 and North East Monsoon 2019 led to breaches in the Supply channels and Tank and Anicut leakages in tank sluices, which were restored on a war footing basis. The Principal Secretary/ Commissioner of Revenue Administration has further stated that the District Collector, Villupuram, has sent a proposal for sanction of Rs.49.90 lakhs (Rupees Forty Nine Lakhs and Ninety Thousand only) towards the expenditure incurred for the temporary restoration works carried out in the flood affected areas in Villupuram District during the South West Monsoon 2019 and North East Monsoon 2019.

2. The Principal Secretary/ Commissioner of Revenue Administration has also stated that the proposal of the District Collector, Villupuram has been examined in detail with reference to the State Disaster Response Fund (SDRF) norms prescribed in G.O. (Ms.) No.380, Revenue department, dated 27.10.2015 and the entire amount of Rs.49.90 lakhs as requested by the District Collector, Villupuram, is covered under State Disaster Response Fund (SDRF). The Principal Secretary/ Commissioner of Revenue Administration has therefore requested to sanction a sum of Rs.49.90 lakhs (Rupees Forty Nine Lakhs and Ninety Thousand only) towards the expenditure incurred for the temporary restoration works carried out in the flood affected areas in Villupuram District during the South West Monsoon 2019 and North East Monsoon 2019.

4. The Government after careful consideration, accept the Proposal of the Principal Secretary/ Commissioner of Revenue Administration and based on the approval of the State Executive Committee accord sanction for a sum of

Rs.49,90,000/- (Rupees Forty nine lakh and ninety thousand) to the District Collector Villupuram towards the expenditure incurred for the temporary restoration works carried out in the flood affected areas in Villupuram District during the South West Monsoon 2019 and North East Monsoon 2019.

5. The amount sanctioned in paragraph 4 above shall be debited to the following head of account:-

"2245 Relief on Account of Natural Calamities – 02 Flood, Cyclones, etc., - 800 Other Expenditure – State's Expenditure – BO Repairs and Restoration works in Flood affected Districts 309 Grant – in – Aid 09 Others."

6. Necessary funds of Rs.49.90 lakhs will be provided in RE/FMA 2020-2021. Pending provision of such funds, the Additional Chief Secretary/ Commissioner of Revenue Administration is authorized to draw and disburse the amount. The expenditure shall be brought to the notice of the Legislative Assembly by Specific inclusion in the Supplementary Estimates 2020-2021. The Additional Chief Secretary/ Commissioner of Revenue Administration is requested to sent necessary proposal for inclusion of the expenditure in Revised Estimate 2020-2021 and also to send necessary draft Explanatory Note for specific inclusion in the supplementary Estimate 2020-2021 to Finance (BG-I/Revenue) Department without fail at appropriate time.
