ORDER:

In the reference second read above, the Government in Revenue and Disaster Management Department in the light of the announcements made by the Hon'ble Deputy Chief Minister during Budget Speech 2019-2020, to the Additional Chief Secretary/ Commissioner of Revenue Administration have accorded Administrative and Financial Sanction for a sum of Rs.238,13,24,847/from State Funds for carrying out 12 nos. of Long Term Permanent Flood Mitigation Works in the highly vulnerable areas of Chennai, Tiruvallur, Kancheepuram, Chengalpattu and Cuddalore districts after reserving Rs.46.00 crores to meet out cost of Land Aquisition and Environmental Impact Assessment works. Accordingly, the Principal Secretary / Commissioner of Revenue Administration has authorized the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public Works Department to draw and disburse Rs. 238,13,24,847/- for carrying out the above sanctioned Long Term Flood Mitigation works.

2. The Principal Secretary/Commissioner of Revenue Administration has stated that the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public Works Department have submitted surrender proposal for the Financial year 2019-2020 towards the unspent amount in the above sanctioned amount of Rs. 238,13,24,847/- (Rupees Two Hundred and Thirty Eight Crore Thirteen Lakhs Twenty Four Thousand Eight Hundred and Forty Seven only) as below in the following Head of Account:-

- 3. According to the Additional Chief Secretary/ Commissioner of Revenue Administration the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public Works Department had stated that the entire sanctioned amount could not be spent fully for the following reasons
 - The Government Order for the Administrative and Financial sanction was accorded only during 09/2019 i.e., on 27.09.2019.

- The works were able to be commenced only during January 2020 after the tender process, thereby having only 3 months working period during the financial year 2019-2020.
- The works were entrusted to the successful bidders with a contract period of 12 to 24 months depending upon the value of the works and items involved in the works.
- 4. The Additional Chief Secretary/ Commissioner of Revenue Administration has stated that now the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public Works Department has requested to provide funds to the tune of Rs.160,21,23 thousands (Rs.160.22 crores) out of the total unspent and surrendered amount of Rs.1,87,72,41/- thousands (Rs.187.72 crores) for the works that are being carried out and programmed to be executed during the financial year 2020-21. The Engineer-in-Chief had also enclosed the work wise financial and physical progress report upto July 2020 for all the twelve sanctioned works while also indicating that there is a liability of Rs.58.32crores towards the works executed from April 2020 to July 2020.
- 5. The Principal Secretary/Commissioner of Revenue Administration has therefore requested that a sum of Rs.160.22 crore may be released from the total unspent and surrendered amount of Rs.187.72 crore and that the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public

Works Department may be authorised to draw and disburse the above amount of Rs.160.22 crores under the head of account as detailed below:-

The Government after careful consideration, accept the proposal of the Principal Secretary/ Commissioner of Revenue Administration and authorised to incurre Rs.111.46 crore (Rupees One hundred eleven crore and forty six lakhs only) from out of the total unspent and surrendered amount of Rs.187.72 crore for the works to take up Long Term Permanent Flood Mitigation Works in the highly vulnerable areas of Chennai, Tiruvallur, Kancheepuram, Chengalpattu and Cuddalore Districts being carried out and programmed to be executed during the financial year 2020-2021 by the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public Works Department.

7. The amount authorised in paragraph 6 above shall be debited to the following head of account:-

- 8. Necessary additional funds of Rs.111,46,00,000/- will be provided in Revised Estimate/Final Modified Appropriation 2020-2021. Pending provision of such funds, the Additional Chief Secretary/ Commissioner of Revenue Administration is authorized to draw and disburse the amount to the Engineer-in-Chief, Water Recourses Department & Chief Engineer (Gen), Public Works Department. However, this expenditure shall be brought to the notice of the Legislature by the way of Specific Inclusion in the Supplementary Estimates 2020-2021. The Additional Chief Secretary/ Commissioner of Revenue Administration is also directed to include the expenditure sanctioned above, while sending the budget proposal for Revised Estimate/Final Modified Appropriation 2020-2021 and also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2020-2021 to Finance (BG.I/Revenue) Department at the appropriate time without fail.
