ORDER:

In the letter fourth read above, the Principal Secretary/Commissioner of Revenue Administration has stated that, after heavy inundations and damages experienced in Chennai city and suburbs during 2021 North East Monsoon floods, the Government constituted an Advisory committee for the management and mitigation of flood risk in Chennai. The Committee submitted its interim report with suggestions on short, medium and long-term solutions based on their field visits to Greater

Chennai Corporation area and elaborate consultation meeting with the key stake holders and Residential Welfare Associations (RWAs).

2. The Principal Secretary/ Commissioner of Revenue Administration has also stated that, a meeting of the Committee constituted to give concurrence to invite tender for implementation of the mitigation works which are essential to avoid flooding in vulnerable areas in Chennai City and its suburbs was chaired by the Additional Chief Secretary to Government, MA&WS department on 23.03.2022 in which the Secretaries of all the line departments, Finance, Revenue, Commissioner of Revenue Administration and Head of the Departments attended. During the above meeting, the Committee resolved that the following prioritised flood mitigation works proposed by the Line Departments / Agencies amounting to Rs.467.20 crore may be implemented before the onset of Northeast Monsoon 2022 and that the expenditure towards the mitigation works cleared by the Committee may be met from the funds allotted for mitigation of floods in Chennai city for the year 2022-2023.:-

As per the recommendations of the 15th Finance Commission and the guidelines on constitution and administration of State Disaster Mitigation Fund issued in the Government Order first read above, based on the guidelines of Ministry of Home Affairs, Government of India, 20% of the State Disaster Risk Management Fund shall be allocated for State Disaster Mitigation Fund. Of this 50% could be utilised for mitigating a single hazard and 10% of the same could be utilised for Non-structural measures in a year. Further, a sum of Rs.100 Crore per year has been earmarked towards catalytic assistance for reducing Urban Flooding in Chennai City. In this context, a total sum of Rs.478.80 Crore could be utilised for mitigation measures as detailed below:-

The Principal Secretary/ Commissioner of Revenue Administration is directed to include the expenditure sanctioned above, while sending the Budget Proposal of Revised Estimate/Final Modified Appropriation 2022-2023 and also to send necessary Explanatory Notes to Finance

(Revenue/BG-I) Department for including the above expenditure in the Supplementary Estimates 2022-2023 without fail.
